DISCLOSURE UNDER RULE 2.10(C) OF THE CODE

On 20 June 2023, the board of Bidco and the board of Lookers announced that they had reached agreement on the terms and conditions of a recommended cash offer by Bidco for the entire issued and to be issued ordinary share capital of Lookers pursuant to Rule 2.7 of the Takeover Code (the “**Offer**”), to be implemented by means of a Court-sanctioned scheme of arrangement under Part 26 of the Companies Act 2006 (the “**Scheme**”) (the “**Rule 2.7 Announcement**”).

Capitalised terms used in this announcement, unless otherwise defined, shall have the meanings given to them in the Rule 2.7 Announcement.

As set out in the Rule 2.7 Announcement, Bidco had received irrevocable undertakings to vote in favour of the Scheme at the Court Meeting and the Resolutions at the General Meeting from the Lookers Directors, in respect of their own entire beneficial holdings and their connected persons and Bidco had also received certain letters of intent to vote in favour of the Scheme at the Court Meeting and the Resolutions relating to the Offer at the General Meeting.

Irrevocable Undertakings – Mark Raban, Duncan McPhee and Oliver Laird

The irrevocable undertaking given by Mark Raban related to 294,348 Lookers Shares, representing approximately 0.1% of the issued share capital of Lookers as at 19 June 2023 (being the latest practicable date prior to the publication of the Rule 2.7 Announcement).

The irrevocable undertaking given by Duncan McPhee related to 174,562 Lookers Shares, representing approximately 0.0% of the issued share capital of Lookers as at 19 June 2023 (being the latest practicable date prior to the publication of the Rule 2.7 Announcement).

The irrevocable undertaking given by Oliver Laird related to 49,818 Lookers Shares, representing approximately 0.0% of the issued share capital of Lookers as at 19 June 2023 (being the latest practicable date prior to the publication of the Rule 2.7 Announcement).

Bidco announced on 21 June 2023 that:

- Mark Raban had acquired a beneficial interest in 3,330 Lookers Shares as a result of his election to participate in Lookers’ dividend reinvestment plan; and

- Duncan McPhee had acquired an aggregate of 8,762 Lookers Shares from the exercise of his outstanding SAYE options and as a result of his election to participate in Lookers' dividend reinvestment plan.

Mark Raban has advised Bidco that he has since acquired a beneficial interest in 93,709 Lookers Shares as a result of Lookers' bonus arrangements (the "**Additional CEO Shares**").

Duncan McPhee has advised Bidco that he has since acquired a beneficial interest in 58,307 Lookers Shares as a result of Lookers' bonus arrangements (the "**Additional COO Shares**").

Oliver Laird has advised Bidco that he has since acquired a beneficial interest in 58,307 Lookers Shares as a result of Lookers' bonus arrangements (the "**Additional CFO Shares**").

As a result, with effect from completion of the acquisition of the Additional CEO Shares, the Additional COO Shares and the Additional CFO Shares:

- the irrevocable undertaking given to Bidco by Mark Raban is deemed to apply in respect of the Additional CEO Shares and is now given in respect of his entire holding of 391,387 Lookers Shares, representing approximately 0.1 per cent. of the issued share capital of Lookers as at the close of business on 23 June 2023 (being the latest practicable date prior to the date of this announcement);
- the irrevocable undertaking given to Bidco by Duncan McPhee is deemed to apply in respect of the Additional COO Shares and is now given in respect of his entire holding of 241,631 Lookers Shares, representing approximately 0.1 per cent. of the issued share capital of Lookers as at the close of business on 23 June 2023 (being the latest practicable date prior to the date of this announcement); and
- the irrevocable undertaking given to Bidco by Oliver Laird is deemed to apply in respect of the Additional CFO Shares and is now given in respect of his entire holding of 108,125 Lookers Shares, representing approximately 0.0 per cent. of the issued share capital of Lookers as at the close of business on 23 June 2023 (being the latest practicable date prior to the date of this announcement).

Letter of Intent – J O Hambro Capital Management Limited and Artemis Investment Management LLP

The letter of intent given by J O Hambro Capital Management Limited ("**J O Hambro**") related to 30,686,279 Lookers Shares, representing approximately 8.0% of the issued share capital of Lookers as at 19 June 2023 (being the latest practicable date prior to the publication of the Rule 2.7 Announcement).

Bidco announced on 21 June 2023 that J O Hambro had advised Bidco that it had disposed of 8,000,000 Lookers Shares and on 23 June 2023 that J O Hambro had advised Bidco that it had disposed of a further 1,500,000 Lookers Shares, resulting in the letter of intent given by J O Hambro being given in respect of 21,186,279 Lookers Shares, representing approximately 5.6 per cent of the issued share capital of Lookers as at the close of business on 22 June 2023 (being the date prior to the date of the 23 June 2023 announcement).

Following Bidco's announcements on 21 June 2023, J O Hambro has since advised Bidco that it has disposed of an additional 1,500,000 Lookers Shares (the "**Sold Shares**").

As a result, with effect from completion of the sale of the Sold Shares, the letter of intent given to Bidco by J O Hambro, has ceased to apply in respect of the Sold Shares and is now given in respect of its remaining holding of 19,686,279 Lookers Shares, representing approximately 5.2 per cent of the issued share capital of Lookers as at the close of business on 23 June 2023 (being the latest practicable date prior to the date of this announcement).

The letter of intent given by Artemis Investment Management LLP ("**Artemis**") related to 40,464,128 Lookers Shares, representing approximately 10.6% of the issued share capital of Lookers as at 19 June 2023 (being the latest practicable date prior to the publication of the Rule 2.7 Announcement).

Artemis has advised Bidco that it has disposed of 7,000,000 Lookers Shares (the "**Sold Shares**").

As a result, with effect from completion of the sale of the Sold Shares, the letter of intent given to Bidco by Artemis, has ceased to apply in respect of the Sold Shares and is now given in respect of its remaining holding of

33,464,128 Lookers Shares, representing approximately 8.8 per cent of the issued share capital of Lookers as at the close of business on 23 June 2023 (being the latest practicable date prior to the date of this announcement).

Therefore, the total number of Lookers Shares which are subject to irrevocable undertakings or letters of intent received by Bidco from Lookers Shareholders has reduced to 142,877,920 Lookers Shares, representing approximately 37.4 per cent of the issued share capital of Lookers as at the close of business on 23 June 2023 (being the latest practicable date prior to the date of this announcement).

The Offer relates to the shares of a company registered under the laws of England and Wales and is being made by way of a scheme of arrangement provided for under Part 26 of the Companies Act. The Offer, implemented by way of a scheme of arrangement, is not subject to the tender offer rules or the proxy solicitation rules under the U.S. Exchange Act. Accordingly, the Offer is subject to the disclosure requirements and practices applicable to a scheme of arrangement involving a target company in England with its securities admitted to trading on the London Stock Exchange, which differ from the requirements of U.S. tender offer and proxy solicitation rules. If, in the future, Bidco exercises its right to implement the Offer by way of a Takeover Offer and determines to extend the Takeover Offer into the United States, the Offer will be made in compliance with applicable U.S. laws and regulations including Sections 14(d) and 14(e) of the U.S. Exchange Act and Regulations 14D and 14E thereunder. Such a Takeover Offer would be made in the United States by Bidco (and/or a nominee of Bidco) and no one else.

The financial information included in this announcement has been prepared in accordance with accounting standards applicable in the United Kingdom and thus may not be comparable to financial information of U.S. companies or companies whose financial statements are prepared in accordance with U.S. generally accepted accounting principles.

An Opening Position Disclosure must contain details of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s). An Opening Position Disclosure by a person to whom Rule 8.3(a) of the Code applies must be made by no later than 3.30 p.m. (London time) on the 10th business day (as defined in the Code) following the commencement of the offer period and, if appropriate, by no later than 3.30 p.m. (London time) on the 10th business day (as defined in the Code) following the announcement in which any securities exchange offeror is first identified. Relevant persons who deal in the relevant securities of the offeree company or of a securities exchange offeror prior to the deadline for making an Opening Position Disclosure must instead make a Dealing Disclosure.

Under Rule 8.3(b) of the Code, any person who is, or becomes, interested in 1 per cent. or more of any class of relevant securities of the offeree company or of any securities exchange offeror must make a Dealing Disclosure if the person deals in any relevant securities of the offeree company or of any securities exchange offeror. A Dealing Disclosure must contain details of the dealing concerned and of the person's interests and short positions in, and rights to subscribe for, any relevant securities of each of (i) the offeree company and (ii) any securities exchange offeror(s), save to the extent that these details have previously been disclosed under Rule 8 of the Code. A Dealing Disclosure by a person to whom Rule 8.3(b) of the Code applies must be made by no later than 3.30 p.m. (London time) on the business day (as defined in the Code) following the date of the relevant dealing.

If two or more persons act together pursuant to an agreement or understanding, whether formal or informal, to acquire or control an interest in relevant securities of an offeree company or a securities exchange offeror, they will be deemed to be a single person for the purpose of Rule 8.3 of the Code.

Opening Position Disclosures must also be made by the offeree company and by any offeror and Dealing Disclosures must also be made by the offeree company, by any offeror and by any persons acting in concert with any of them (see Rules 8.1, 8.2 and 8.4 of the Code).
